**Subject: Your Ref.: 110/2021\_MEDAC letter on safety at work for fishers in the Mediterranean**

Dear Mr Buonfiglio,

Thank you for your letter and the opinion on the question of jurisdiction of waters in the Mediterranean Sea.

The Commission is aware of the incidents involving Italian fishing vessels and Libyan vessels in the Mediterranean. We have closely followed the recent incident, mentioned in your letter, involving the fishing vessel "Aliseo", as well as the previous incident involving the "Antartide" and "Medinea". The Commission attaches great importance to the safety of the EU operators on-board their vessels.

The Commission is aware that there are maritime zones claimed by Libya that are contested by other States. Matters appertaining to the determination of maritime zones is a competence that belongs to Member States. This competence includes not only the conclusion of international maritime boundary agreements but also cases such as the situation regarding the maritime zones of Libya. The Commission, however, fully supports the delimitation of maritime zones among all relevant States in accordance with international law.

As for the legal clarity and certainty for the operators of the vessels requesting a fishing license, the national authorities granting the fishing license need to provide information and warn individual operators about the unstable situation in the region and the risks arising from fishing in waters subject to overlapping claims in order to minimize the potential danger for those vessels.
